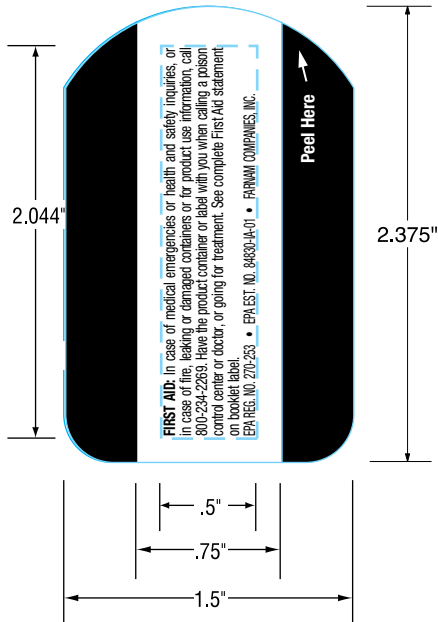


# 8 PANEL - FARNAM HORSE LEAFLET

**ENVIRONMENTAL HAZARDS:** This product is extremely toxic to fish and aquatic invertebrates. Do not apply directly to or near water. Drift and run-off may be hazardous to fish in water adjacent to treated areas. Do not contaminate water when disposing of equipment washwaters or rinsate. Do not use on foals under 12 weeks old. Do not allow product to contact animal's eyes, nose, mouth, or sores during application. Do not apply near eyes and mouth. Apply sparingly around ears. **Wash hands with soap and water promptly after use.**

To protect horses from House Flies, Face Flies, Horse Flies, Stable Flies, Black Flies, Horn Flies, Deer Flies, Lice and Ticks and from biting gnats such as Punkies and No-see-ums: thoroughly brush the horse's coat prior to application to remove loose dirt and debris. For best results shampoo and rinse; wait until coat is completely dry and apply Endure® Roll-On for Horses.

Remove cap from bottle. May be applied around superficial wounds and abrasions or spot treat areas of the horse where flies gather. Avoid direct application to eyes, nose and mouth. Replace cap after use.

Repeat application as necessary but not more often than once every 5 to 7 days. Wash hands with soap and water after use.

**STORAGE AND DISPOSAL**

**STORAGE:** Do not contaminate water, food or feed by storage or disposal. Store in a cool, dry place inaccessible to children and pets.

**DISPOSAL:** Nonrefillable container. Do not reuse or refill this container. **If empty:** Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain.
